

I, Marki Rowley, Millard County Clerk, hereby give notice pursuant to Utah Election Code 20A-5-101 for the 2016 election.

- The Declaration of Candidacy filing period for qualified political party candidates begins on Friday, March 11, 2016 and ends at 5:00 p.m., Thursday, March 17, 2016, and;
- The Declaration of Candidacy filing period for state and local school board candidates begins on Monday, January 4, 2016 and ends at 5:00 p.m., Thursday, March 17, 2016, and;
- The Declaration of Candidacy filing period for justices and judges of a court of record begins Friday April 1, 2016 and ends at 5:00 p.m., Friday, April 15, 2016, and;
- The Declaration of Intent to Gather Signatures period for qualified political party candidates begins on Monday, January 4, 2016 and ends at 5:00 p.m., Thursday, March 17, 2016, and;
- Candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office.
